One day, Linda was cleaning her home with the TV muted when she happened to look up to see the word cholangiocarcinoma on the screen. It was a story about the Mike Shane, who died of cholangiocarcinoma in 2019, and the <u>memorial fund</u> established in his honor to fund second opinions for patients with complex conditions.
